

Chapter 2: Role of Warehouse Managers

6 basic tenets:

accuracy;
cost control;
cleanliness;
efficiency;
safety;
security.

Warehouse managers are expected to recognize and balance other **trade-offs** as follows:

- increased throughput vs. reduction in labour costs;
- storage density vs. quicker pallet extraction;
- manual vs. automated processes;
- increased pick rates vs. accuracy;
- inventory holding costs vs. cost of stock outs;
- speed vs. safety.

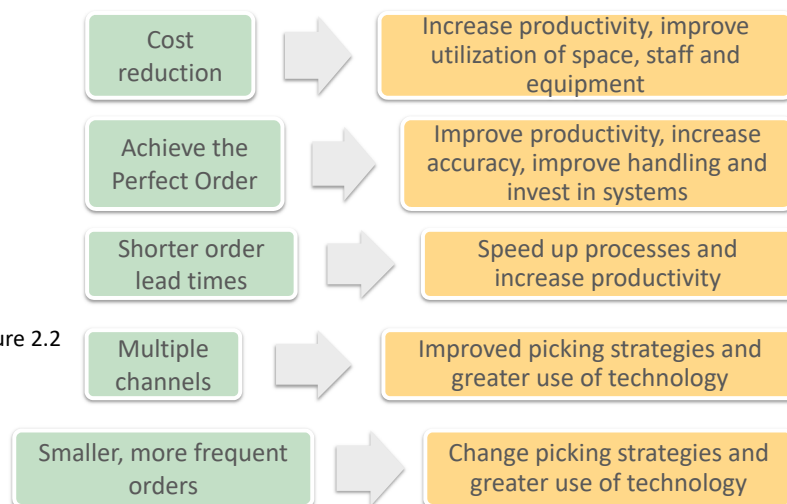
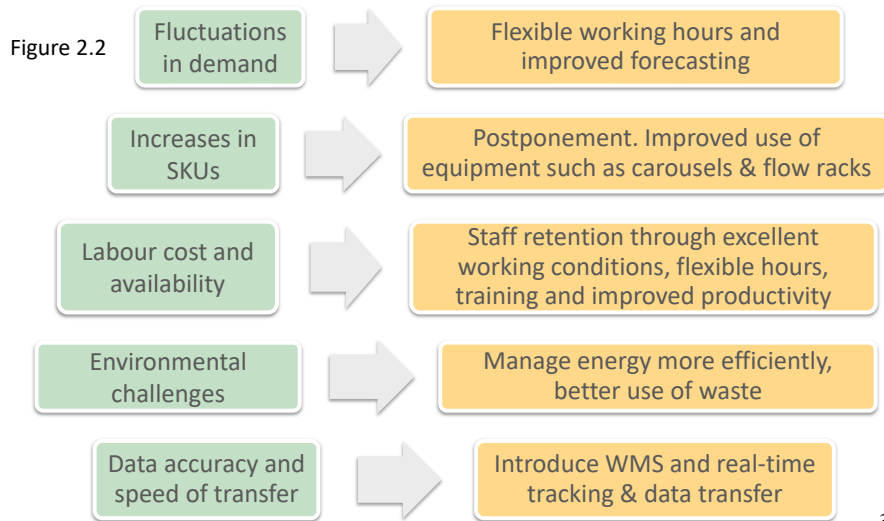

Warehouse Challenges



Lean Warehousing

- The concept of 'lean' comes from the manufacturing sector, more specifically the automotive industry, and is very much associated with Toyota.
- 'Lean' is now being applied not only in manufacturing but also within the public sector and the supply chain.
- The idea behind lean is to remove any activity that uses resources but doesn't create any additional value.

Examples

- half-height and quarter-height pallets taking up space in two-metre-high locations; 零板佔用儲位
Solution: moving smaller pallets to other locations, reducing beam heights or adjustable heights
- part pallets of the same product spread over a number of different locations; 品項儲存於不同儲位
Solution: Consolidate the pallets. Tradeoff between labour cost and storage space. 多儲位的優點
- over 10 per cent of the stock was obsolete. 呆料庫存
Solution: Decisions have to be made in conjunction with the finance department to dispose of obsolete product

Seven Wastes or Muda

- transportation (driving an empty forklift) 空車行駛
- defects (time spent correcting errors such as misspicks) 揀錯
- inventories (congestion at the inbound and outbound areas) 進出貨區域擁擠
- motion (interrupting movement such as staging product before put-away) 入庫作業中斷
- waiting time (bottlenecks at pick locations) 等候揀貨
- overproduction (holding too much inventory) 庫存過多
- overprocessing (performing unnecessary steps such as labelling and checking) 非必要的檢查

Effective Supervisors and Managers

- Communication skills
 - Ability to delegate effectively 用人
 - Motivation skills
 - Problem-solving skills

 - Ability to train others

- ability to work in a group;

Training

- ensure that all staff receive an induction: showing the end-to-end supply chain and how each step impacts the final customer
- undertake a training needs analysis to identify which staff require specific types of training. There are always areas in which staff need to be trained – **the trick is in identifying them.**
- all staff operating mechanical handling equipment must be trained on each individual piece of equipment and obtain a licence from the authorities

Attracting and Retaining Employees

- Many firms see monetary incentives as being key to staff recruitment and retention.
- Surveys suggests otherwise with active employee involvement in productivity improvement, ... being seen as high on the list. (52)
- Flexible hours, recognition of a job well done, [clean and safe working conditions](#), ... crucial to attracting and retaining staff. (52)
- As warehouses become more technically advanced this will also attract a new breed of warehouse employee – those with an interest in [technology and automation](#). 物流共和國

Warehouse Audit

ISO 9001 – a standard of requirements against which your Quality Management System can be evaluated; 產品或作業的品質管理

ISO 14001 – a standard of requirements that defines and establishes controls to reduce your company's impact on the environment; 環保

ISO 50001 – a standard of requirements that deals with the energy impact of your warehouse operation; 節能

HACCP (ISO 22000) – 食品安全問題的管理系統

OHSAS 18001 (ISO 45001) – a standard of requirements against which your Health and Safety Management System can be evaluated; 職業健康安全

EICC (BRA) – Electronic Industry Code of Conduct 電子產業行為準則

ISO 14001



- ISO 14001是一種標準，用於確定從原材料到客戶的過程中的環境因素，並通過必要的預防措施控制這些因素，並最大限度地減少對環境的危害。ISO 14001是一種管理系統，旨在系統地減少並在可能的情况下消除企業可能對環境造成的損害。
- 優化資源配置、綠色運輸、綠色倉儲、綠色包裝、逆物流

momo致力於發展綠色物流、友善包裝，2020年綠色物流與低碳運輸每月合計減少21.28公噸碳排放。在實踐綠色物流的道路上，momo從倉儲建置、運輸的布局皆將環境永續的理念涵蓋其中，如北區物流中心太陽能發電設置，持續打造綠色自有車隊，引進符合能源效率運輸車輛。

momo不僅建立環境管理系統及運作機制，同時透過教育訓練提升公司內部環境永續意識，如針對同仁積極推動無紙化措施、廢棄物管理及各式節能宣導等。在momo的努力下，2020年雙雙通過ISO 14064-1溫室氣體盤查查證、ISO 14001環境管理系統驗證，實踐建立永續營運綠生活承諾。

HACCP (ISO 22000)

- HACCP制度為世界各國在食品管理政策之共同基準，強調源頭管理模式，從原料處理到產品製造、銷售等完整製程中，評估潛在的危害因素，並加以有效監測以確保食品安全的管理制度。實施HACCP制度的工廠，必須具備對其加工程序中可能發生之**生物性、化學性或物理性**危害，進行詳實之評估分析並研訂對策，確保產品安全品質。
- 包含從食物源頭開始的農場主，到食品與飼料生產、加工、製造的廠商、批發商和零售商，同時也適用於與食品有關的**物流運輸、倉儲配送**、包裝材料供應廠商、農業化學品和食品添加劑供應廠商，甚至涉及食品的服務供應商、餐廳、設備、清潔員也都算在內。



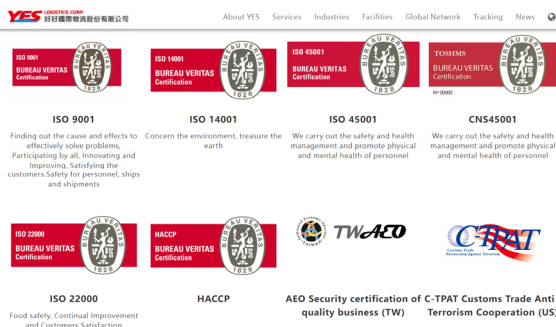
全台物流於2010年領先同業取得食品安全管理系統雙認證，確保從全台物流從食品服務、加工、運輸、儲存、零售和包裝等作業流程中，皆符合食品安全管理體系要求，提供客戶新鮮、安全與衛生商品的良好作業品質。

ISO 45001 (OHSAS 18001)



- ISO 45001是職業安全健康管理體系的ISO標準之一，基於國際勞工組織OHSAS 18001的公約、準則以及國家標準。ISO 45001的目標是為員工**提供安全的作業場所**，進行危害鑑別、風險評估，並確定必要的控制措施，提升人員的**職業衛生安全意識和能力**，以減少職業傷害和疾病，包括促進和保護身心健康。

Electronic Industry Code of Conduct

- 惠普、戴爾和IBM等共同發表電子產業行為準則(EICC)，旨在電子行業的全球供應鏈中，建立標準化的社會責任感行為規範。該準則由一系列的基本規範組成，涉及勞工和招聘、健康安全、環境責任、管理系統和道德規範等。
- 2017年10月EICC 宣布組織改造同時亦改名為責任商業聯盟 (Responsible Business Alliance, RBA)



日月光加入EICC後將與供應商共同遵守EICC行為準則，並推動供應管理「SMILE供應鏈到ART供應網路」行動計畫，表達共創綠色永續供應鏈的決心。日月光表示，未來將關注供應鏈的綠色管理包括：一、原物料的綠色尋源與採購。二、資本設備與耗材的綠色支出。三、運輸與倉儲的綠色物流服務，引領供應商共同承擔環境、員工等社會責任。從商業道德、安全衛生、環境保護、管理系統等方面帶動整體供應鏈的綠化升級與永續經營目標。

ISO 27001



有關資訊安全管理系統架構、實施、維護以及持續改善上的要求，目的是幫助組織可以使其保管的資訊資產更加安全。ISO/IEC 27001包括的不只是IT部門而已，ISO/IEC 27001會要求進行以下的管理：

- 系統性地檢驗組織的資訊安全風險，考慮其威脅、弱點以及影響。
- 包含客戶隱私，企業機密以及資訊科技層面，更包含法律，人員管理，物資管理等諸多方面，每個與資訊相關的組織都應該進行相關的資訊安全風險評估，藉由相關的指導和建議實施適當的資訊安全管控。

新竹物流為落實客戶資料保護，於99年即成立個資保護執行委員會，於99年通過ISO27001，今年再次通過ISO27001與BS10012兩國際驗證標準。成為台灣第一家同時通過ISO27001與BS10012認證之物流商；代表新竹物流對個資的管理與資訊安全是為企業首要議題，肯定其對客戶資料的重視與善盡保護責任的努力。
